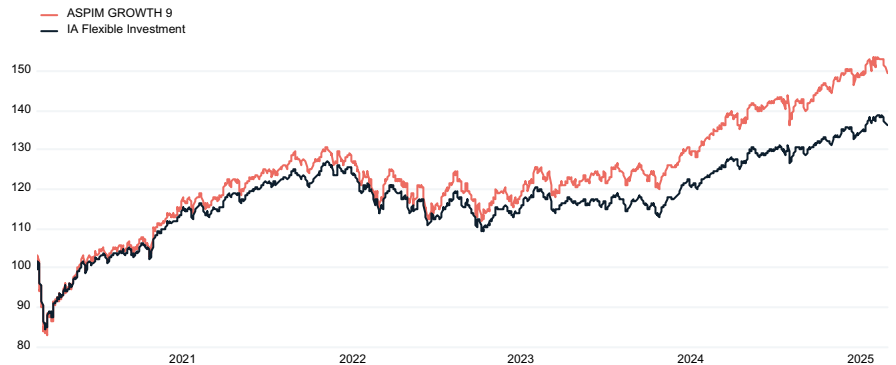

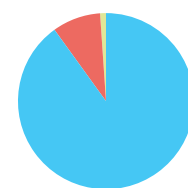

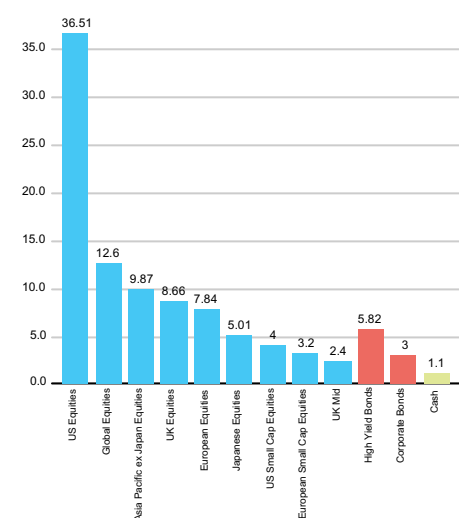

## ASPIM Prima Funds

There is 0% investment management fee paid to Albemarle Street Partners when accessing the Prima Adventurous fund through our Model Portfolio Service. The 0.10% AMC is paid to the ACD, Margetts Fund Management, for their services.
