Performance since inception %



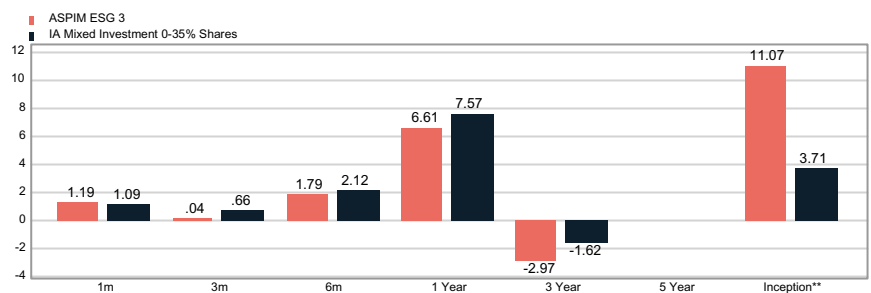

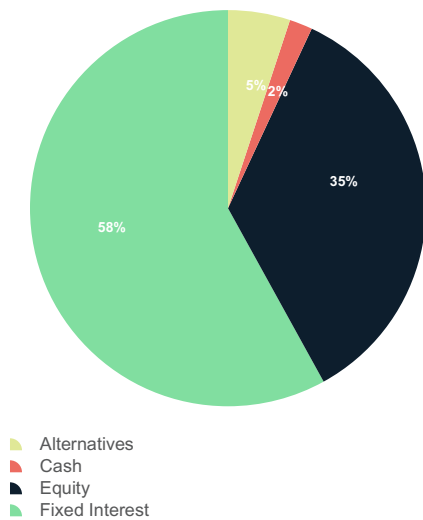

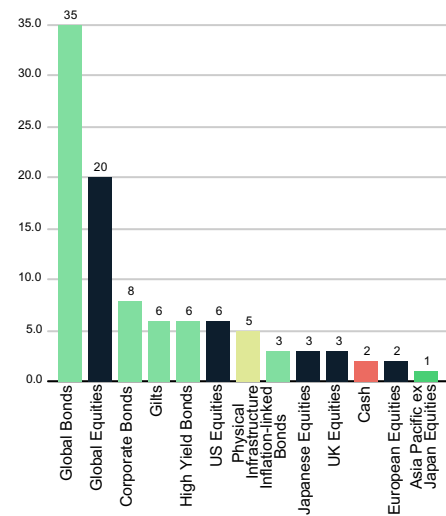
